Objective: To promote mental, emotional, and behavioral well-being.

Area of Opportunity: Experiencing "Fair or Poor" Mental Health

- Cass County reports that 18.8%% of the population believes that their overall mental health is "fair or poor."
- This is a significant increase since the 2013 rate of 7.8%. The U.S. rate is 13.4%.

- ☐ The prevalence of obesity is worse than found across the state and US.

- ☐ Cass County's reported rate for use of illicit drugs in the past month is 3.0%.
- Only 4% of Cass County population has ever sought professional help for an alcohol/drug related problem.

- ☐ A total of 43.8% of Cass County adults report some type of difficulty or delay in obtaining health care services in the past year.
- ☐ This is significantly higher than the US rate of 35%.

Create a hub for information sharing to be used by general public, social service providers and consumers. Expand and promote digital platform (telehealth services, remote patient monitoring, etc.). Develop in-home programming to include remote patient monitoring and para-medicine.
