

VISITOR RESTRICTIONS POLICY



HOSPITAL VISITING HOURS: 6 AM—8 PM

All patients and visitors will be required to self-screen when entering the facility, and required to wear a mask. We also ask that you practice social distancing, and practice good hand hygiene.
Symptomatic visitors will be asked to leave.

RESTRICTIONS	
<ul style="list-style-type: none"> – <i>Visitors or support persons must be age 18 or older. Children are not allowed as visitors.</i> – <i>Support person(s) for non-COVID patients may go to Café Express as needed to purchase meals during their visit.</i> – <i>Healthy clergy members are allowed as an additional approved visitor for any patient during visiting hours.</i> 	
Emergency Room	Two healthy support people (must stay in the patient's room, not allowed to wander through the hospital)
OB unit (Family Birth Center)	Two healthy support people for the patient's entire stay (Can choose to leave but will not be allowed to return if leaving after 8 pm; can return at 6 am the following day) Exceptions: <ul style="list-style-type: none"> – <i>Visitors for COVID-positive patients cannot wander outside the patient's room. They must exit promptly after their visit.</i>
Surgery	Adult patients: One healthy support person Pediatric patients: Two healthy support people (must stay in the patient's room, not allowed to wander through the hospital) Exceptions: <ul style="list-style-type: none"> – <i>No visitors allowed for pain management patients.</i>
Med/Surg and ICU <i>Patients staying overnight at the hospital</i>	Any two healthy support people at bedside at any one time Exceptions: <ul style="list-style-type: none"> – <i>Any patient who is a child under the age of 18 must have an adult with them at all times.</i> – COVID-POSITIVE PATIENTS <i>Must have the two same healthy support people, for the patient's entire stay who cannot wander outside the patient's room. They must exit promptly after their visit.</i>
Cancer Care Center	Two healthy support people
Therapy Services	One healthy support person (Must wait in the LMH Main Lobby. If family desires, LMH staff will collect them to discuss the plan of care)
Medical Imaging; Laboratory	One healthy support person, only if required to assist the patient (Patients should come alone whenever possible) Exception (Medical Imaging only): <ul style="list-style-type: none"> – <i>Patients having a biopsy are allowed one healthy support person.</i>
Physician Offices and off-site Clinics	Adult patients: One healthy support person; children not allowed as visitors Pediatric patients: Two healthy support people Exceptions: <ul style="list-style-type: none"> – <i>Any patient who is a child under the age of 18 must have an adult with them at all times.</i> – <i>Women's Health Center prenatal patients under the age of 18 may bring one healthy support person, plus a parent or guardian. If NOT a prenatal patient, then only the parent or guardian may come with them.</i>
